# THE ACADEMIC EDUCATIONAL PROGRAM

The educational program at Roxborough Memorial Hospital School of Nursing prepares the graduate to sit for the National Council of State Boards of Nursing Licensure Examination to practice as a Registered Nurse.

In the first year of study, students are provided with a broad base of knowledge of the biopsychosocial, cultural and spiritual influences on health throughout the human life cycle. Students are guided to apply new knowledge in order to assess patient needs and to develop and implement individualized plans of nursing care in a variety of clinical settings.

In the second year, students build on their first year studies and incorporate more advanced nursing knowledge to create plans for comprehensive care in complex nursing situations.

All clinical practice settings have been selected to enhance the academic offerings, to reinforce classroom learning and to facilitate achievement of the desired goal of excellence in nursing practice.

Student levels of achievement are evaluated through observation and testing. At graduation, the student is prepared to practice as a professional nurse capable of making sound decisions in the provision of nursing care.

# HIGH SCHOOL REQUIREMENT POLICY

All applicants must have achieved a high school diploma, General Educational Development Test (GED), or the equivalent. If there is reason to believe that the diploma is not valid, Admissions will pursue efforts to verify the validity of the high school completion. That will include contacting the school for verification. In addition, Admissions also has the option of checking with the state where the document was issued to verify the source and or access the National Center for Education Statistics (NCES) database.

# **ADMISSION REQUIREMENTS – COLLEGE**

The following college courses are required for admission as prerequisites with a grade of "C" or above:

- 1. College Algebra, higher level College Math, or Statistics (3 Credits)
- 2. \*Anatomy & Physiology I (4 Credits)
- 3. \*Anatomy & Physiology II (4 Credits)
- 4. Chemistry (4 Credits) If a grade of "C" or above was not achieved in high school Chemistry
- 5. Developmental Psychology (3 Credits)
- 6. English Composition (3 Credits)
- 7. Introduction to Psychology (3 Credits)
- 8. Microbiology (4 Credits)
- 9. Nutrition (3 Credits)
- 10. Sociology (3 Credits)

# **TRANSFER POLICY**

For eligibility, a student must meet all admission requirements for the Roxborough Memorial Hospital School of Nursing. Transfer students are required to begin courses at the Nursing 100 level. Only Prerequisite courses transfer. Prior nursing courses do not transfer. Any student that has attended a previous nursing program must provide documentation stating that they were not dismissed from that program for a disciplinary matter. Additional documentation may be required.

# NON-DISCRIMINATORY POLICY

Admission to the School of Nursing is without regard to race, color, religion, sex, sexual orientation, national origin, marital status, age, disability, or any characteristic protected by law.

# **ADMISSION PROCEDURE**

- Submit completed application with required non-refundable fee.
- Submit official high school transcripts, GED scores, or the equivalent.
- Submit official college transcripts from all schools attended.
- The ATI TEAS exam is required. The benchmark score of 58.7% must be reached within two attempts in a one-year period.
- Attendance at an informational session is required.
- Submit two signed, professional letters of recommendation.
- Applicants will be contacted to schedule an interview prior to application review.

### Additional Requirements:

- College Grade Point Average (GPA) of 2.5 is required in relation to courses taken and grades earned. Individual options may be offered as records indicate.
- Satisfactory references
- Satisfactory Child Abuse; State and Federal Criminal Record; FBI Fingerprinting; OIG; Health Clearance and Drug Testing Clearance
- A Science GPA of 2.5 is preferred for Anatomy & Physiology I and II
- Students who have English as a second language may be required to take the TOEFL examination
- Each applicant is considered on an individual basis.

# TIME COMMITMENT

The nursing curriculum is challenging, labor intensive, and requires more of a commitment and more time than many other courses of study. There are classroom and clinical courses integrated into each semester that are mandatory and require preparation. Students in the School of Nursing are therefore strongly advised to limit their hours of work and/or other non-student commitments during the academic year. Students are expected to be available as designated on the class schedule.

### FIRST YEAR CURRICULUM

#### **Nursing 100 Foundations of Nursing**

This course introduces the student to the role of the professional nurse within the health care delivery system. A holistic framework is used to assist the student to identify health care needs of diverse individuals. There is an emphasis on the importance of communication and collaboration with the patient and with other health care professionals to provide comprehensive care. The course introduces the student to teaching and learning principles used to assist patients to achieve optimal health. The course explores the concept of critical thinking and clinical judgement in the context of clinical practice and emphasizes legal, ethical, spiritual, and cultural bases for professional practice. The student is provided with the theoretical and clinical foundations necessary to deliver safe, quality care based on evidence within the framework of the nursing process. The student is expected to demonstrate basic nursing skills based on best practices in the clinical laboratory and in various health care agencies.

#### Nursing 200 Medical-Surgical Nursing I and Mental Health Nursing

This course uses a holistic framework and the nursing process to help the student to care for patients who have a variety of disease processes. In the medical-surgical module, the student applies knowledge of pathophysiology, physical assessment, and pharmacology in order to plan evidence-based care for hospitalized patients. In the mental health module, the student cares for patients experiencing alterations of behavior, mood, and cognition. Emphasis is placed on therapeutic communication and use of the self as therapeutic agent. Students are expected to apply teaching and learning principles to patient-centered education. There is continued emphasis on communication, collaboration, critical thinking, clinical judgement and provision of safe, quality care within the professional role in order to assist patients to achieve optimal health.

### SECOND YEAR CURRICULUM

#### Nursing 300 Medical-Surgical Nursing II

This course uses a holistic framework and the nursing process to assist the student to provide evidence-based care for patients with acute and chronic illnesses. As the course progresses, the student provides care for patients experiencing the impact of complex multisystem pathophysiology. The course highlights the impact of these illnesses on patients and their families. There is continued emphasis on communication, collaboration, critical thinking, clinical judgement, and provision of safe, quality care within the professional role. Students are expected to advocate for their patients and assist them to achieve optimal health and independence.

Placement: Required Course, Second Year

Credits: 12 Hours: Theory 90 hours (In-class)/Clinical 270 hours

Pre-requisites: Nursing 100 and Nursing 200

### Nursing 400 Management of Care

The first part of this course uses a holistic framework and the nursing process to focus the student on the provision of care to childbearing and childrearing families. Emphasis is placed on expected changes of pregnancy and on unanticipated complications. Also emphasized are normal growth and development from infancy through adolescence and the impact of illness on infants, children, adolescents, and their families. Students are expected to use their nursing knowledge and teaching skills to enhance the health of new and established families. There is a continued emphasis on communication, collaboration, critical thinking, clinical judgement, and provision of safe, quality care within the professional role to assist patients and families to achieve optimal health. The second part of this course is designed to broaden the student's perspective of the nurse's role in influencing and improving health care systems. The student is assisted to use evidence-based practice and best practices to manage care for individuals, families, groups, and communities. All previously learned concepts are synthesized as the student prepares to graduate. In addition, emphasis is placed on leadership and management issues which impact health care. All learning experiences are designed to ease the transition of the student to the role of graduate nurse.

# **VETERAN'S BENEFITS 2024-2025**

Roxborough Memorial Hospital School of Nursing is a VA approved institution. VA eligible students can use their benefits at Roxborough Memorial Hospital School of Nursing to help finance their education.

Roxborough Memorial Hospital School of Nursing will not impose any penalty, including the assessment of late fees, the denial of access to classes, libraries or other institutional facilities or the requirement that a veteran borrow additional funds to meet his or her financial obligations due to the delayed disbursement funding from the VA under Chapter 31 or 33.

The Veteran applying for benefits is responsible for completing the following steps:

- 1. Submit a certificate of eligibility for entitlement to educational assistance no later than the first day of a course of education.
- 2. Submit a written request to use such entitlement.
- 3. Provide additional information necessary to the proper certification of enrollment by the educational institution.
- 4. The VA student is responsible for timely payment of the amount that is the difference between the amount of the student's financial obligation and the amount of the VA education benefit.

# **Credit for Previous Training**

For students that qualify for Veteran's Benefits and assistance, the school maintains written records that indicate that appropriate and program relevant previous education and training has been evaluated and granted, if applicable the VA and the veteran so notified.

# **DEPARTMENT OF DEFENSE (DOD) INFORMATION**

Roxborough Memorial Hospital School of Nursing refrains from high-pressure recruitment practices such as making multiple unsolicited contacts (3 or more) including contacts by phone, email or in person, and engaging in same day recruitment and registration for the purpose of securing service member enrollment.

# **ACADEMIC / ADMINISTRATIVE POLICIES**

# ATTENDANCE

The faculty believes that participation in all classroom and clinical activities promotes excellence in nursing practice. Therefore, attendance is mandatory at all classroom and clinical experiences.

# **GRADUATION AND LICENSURE**

To be eligible for graduation, the student must:

1. Successfully complete all curriculum requirements, including satisfactory clinical performance.

2. Meet all financial and other obligations to the School of Nursing as stated in the Student Handbook.

When a student has successfully completed the program of study, the graduate is then eligible to sit for the National Council of State Boards of Nursing Licensure Examination (NCLEX). Successful completion will result in the right to use the title of Registered Nurse (R.N.).

# **GRIEVANCE PROCEDURE**

# ACADEMIC AND NON-ACADEMIC

Grievances are student issues of perceived infringement upon an individual's rights. Formal grievance policy and procedures are included in the Student Handbook.

# DISMISSAL

An individual grade below 77 in a nursing course and/or unsatisfactory clinical performance denotes failure and requires that the student repeat the course. In addition, each student must maintain a minimum grade point average of 2.0 prior to the beginning of the next academic year to remain in the program. The faculty reserves the right to ask the student to leave the program if the student fails to comply with the standards set forth in the Student Handbook.



# **RIGHTS AND PRIVACY ACT**

Roxborough Memorial Hospital School of Nursing is in compliance with the Family Educational Rights and Privacy Act of 1974 (Buckley Amendment) whereby students have the right to review their records that meet the Act's definition of educational records.

No personally identifiable information from the student will be disclosed without prior written consent of the student except under certain defined conditions by the Act. Only school officials and authorized governmental and accrediting agencies may have access to student records. Requests to disclose information from the student's records must be submitted in writing by the student.

### CONSUMER INFORMATION DISCLOSURE

85% of the class entering in 2020 (Class of 2022 Day option) completed the Program in 16 months (100% of the time). 55% of the class entering in 2021 (Class of 2022 Evening-Weekend option) completed the Program in 22 months (100% of the time).

100% of the respondents from the class of 2022 day option were employed within twelve months of passing the Licensure Exam (NCLEX).

The pass rate on the National Council Licensure Examination (NCLEX) averaged 83.3% for the Class of 2022 Day option and 100% for the Class of 2022 Evening-Weekend option.

Questionnaires distributed to graduates and employers indicate a very high rate of satisfaction in the education and performance of our nurses.

# DIRECTIONS

#### From Center City on I-76 West

Take I-76 west to exit 340A (Lincoln Drive-Kelly Drive). Stay in the right lane and take the ramp leading to Ridge Avenue West. Take Ridge Avenue past five traffic lights. Hospital is on the right hand side of Ridge Avenue past the fifth traffic light.

### From Pennsylvania Turnpike on I-76 East

From the Valley Forge interchange exit take I-476 South to I-76 East (Schuylkill Expressway) toward center city. Take exit 338 (Belmont Avenue-Green Lane). Make a left onto Green Lane and continue up long hill until it intersects with Ridge Avenue. Turn right onto Ridge and follow past three traffic lights. Hospital is on the left side, one block past the third traffic light.



### From Northeast Philadelphia via Route 1

Take Route 1 South to Ridge Avenue West exit. Turn right onto Ridge Avenue past eight traffic lights. Hospital is on right side of Ridge Avenue after Walnut Lane intersection.

### From North Philadelphia

Take Broad Street to Roosevelt Boulevard, and then follow directions from Northeast Philadelphia above.

### **From Mount Airy**

Take Wissahickon Lane to Wayne Avenue. Turn left onto Wayne Avenue. Follow to Walnut Lane. Turn right onto Walnut Lane and drive about three miles (over Wissahickon Avenue and Henry Avenue) to Ridge Avenue. Turn right onto Ridge Avenue. Continue short distance to hospital.

### From I-95 South

Take I-95 South to 676 West toward Central Philadelphia. Take 676 West to I-76 West. Take I-76 West to exit 340A (Lincoln Drive-Kelly Drive). Stay in right lane and take the ramp leading to Ridge Avenue West. Follow Ridge Avenue past five traffic lights. Hospital is on the right side past the fifth traffic light.

### From City Avenue (Route 1) Traveling North

Go under the I-76 bypass and stay in the right hand lane to Ridge Avenue West. Take Ridge Avenue past five traffic lights. Hospital is on the right side of Ridge Avenue past the fifth traffic light.

### **By Bus**

SEPTAs Bus 9 (from Center City) stops in front of the hospital on Ridge Avenue. Bus E (from 69th Street to Germantown) stops at Walnut Lane and Ridge Avenue (one block east of hospital).

Bus 27 (from Center City) stops at Lyceum and Ridge Avenues (five blocks north of hospital).Bus 32 stops at Ridge and Roxborough Avenues (one block north of the hospital).
